A subject was reported being intoxicated at Wildhorse Resort and Casino (WRC) and seen leaving driving a vehicle. The vehicle was later located and a traffic stop was conducted. During the stop I observed signs of impairment coming from the driver. The driver consented to voluntary standardized field sobriety tests (SFST's) where further impairment was observed. The driver was ultimately arrested for DUII and transported to the Umatilla Tribal Police Station. The driver provided two complete breaths into the intoxilyzer to reveal a final BAC of 0.15%. The driver was later cited and released at WRC. The vehicle was released to a sober passenger.
