**Narrative summary**

A witness called in a vehicle as welfare check due to that they saw a male slumped over sitting inside the vehicle. I later arrived on scene and observed a lone male sitting in the driver seat with the vehicle running. Looking in the vehicle I observed an open alcoholic beverage in the center console. The male was woken up and I observed signs of impairment. The male consented to voluntary SFST's where further impairment was observed and was ultimately arrested for DUII. During the wingspan search of the vehicle a pistol was located in the center console. The pistol was seized and later placed into evidence. The male was transported to the Milton-Freewater Police Department. The male provided two complete breaths into the Intoxilyzer revealing a final BAC of 0.10%. The male was then transported to the Umatilla County Jail where he was lodged for DUII. The vehicle was released to a sober friend.
