

Unit #1 (grey Ford pickup) was merging onto the interstate from Exit 165 EB. The driver of Unit #1 blindly changed lanes from the on ramp all the way to the fast lane. Unit #2 (silver Toyota pickup) was already in the fast lane. Unit #1 clipped the front right bumper of Unit #2 mimicking a pit maneuver. Unit #1 left the roadway striking the cable barrier in the median and rolling multiple times. Driver of Unit #1 was wearing his seatbelt and only sustained minor injuires, walked away from the scene. Unit #1 was towed by J&S Towing, and the driver was issued a citation. OSP was assisted by the Morrow County Sheriff's Office, Boardman Police Department, and ODOT.
