Troopers were contacted as we were walking into UTO by a motorist who reported a driving complaint and pointed out the vehicle. I conducted a mere contact in the 11th Street Market after the vehicle stopped there. The adult male occupant/driver presented with indicators of impairment but refused SFST's. Driver consented to Rhors but then went back and forth until I eventually took him into custody without tests. At the Umatilla County Jail, after the Intoxilvzer process, the male provided his breath samples and his BAC registered to be .13 percent by weight. He was lodged for DUII and his vehicle was towed incident to arrest by D&R Auto.
