<b>Narrative summary</b>					
E-CRASH LOG ONLY: Unit 2 & 2A (green Peterbilt towing yellow Freightliner) was a slow moving CMV in the B lane with its hazard lights on. Unit 1 & 1A (white Freightliner pulling white Great Dane trailer) was approaching Unit 2 & 2A from the rear. Unit 2 driver did not recognize that Unit 1 was a slow moving vehicle and tried to make an avoiding maneuver to avoid colliding with 1A but failed. All Units then blocked both eastbound lanes. Unit 1A driver was transported via Life Flight to St. Mary's Hospital in Walla Walla, Washington. Unit 2A driver was checked by EMS on scene and refused transport. Unit 1 & 1A was recovered by Eastern Oregon Towing. Unit 2 & 2A was recovered by RWC Towing. Unit 1 driver was cited for ORS 811.485 (Following too closely). Interstate 84 was closed for approximately four hours. Oregon State Police was assisted by ODOT, Umatilla Tribal Police, Umatilla Tribal Fire, Pendleton Fire and Umatilla County Sheriff's Office.
